- AND WHEREAS, the Revised Recognition order was issued to the institution vide dated 31.05.2015 for B.Ed. course with an annual intake of 100 students with a direction to submit the compliance to the Revised Recognition order on or before 06.08.2015.
- And whereas, the matter was placed before the WRC in its 255th meeting held on 22-24 June, 2016 to verify the compliance of NCTE Regulations, 2014 and the Committee decided to issue show cause notice dt. 20.03.2017.
- And whereas, the institution has not submitted any reply and the matter was placed before the WRC In its 311th meeting held on September 25th - 27th, 2019 and the Committee has decided as follows:-

"The Show Cause Notice was issued to the institution vide letter dated 20/03/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said

- AND WHEREAS, the institution had filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 11.02.2021 has decided as follows:-

"After perusal of the Memoranda of appeal, affidavit, documents on record and oral arguments advanced during the hearing, appeal committee concluded to remand back the case to WRC with a direction to consider the documents submitted in appeal to be sent to them by the appellant and take further necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC all the documents submitted in appeal within 15 days of receipt of orders on the appeal.

The Council hereby remands back the case of KONKAN MUSLIM EDUCATION SOCIETY'S COLLEGE OF EDUCAITON, THANE ROAD, BHIWANDI, THANE, MAHARASHTRA to the WRC, NCTE, for necessary as Indicated above."
