

CONTINUATION ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely COLLEGE OF EDUCATION .ED. KONKAN MUSLIM EDUCATION SOCIETY, H.NO. 158, RAIS HIGH SCHOOL CAMPUS, THANE ROAD, BHIWADI, DIST. THANE, MAHARASHTRA - 421302 vide order No. WRC/5-6/90/120th/2009/57539-57544 DT. 13.07.2009 for conducting B.Ed. (CO-ED.) course with an annual intake of 100 students.

2. AND WHEREAS, the Revised Recognition order was issued to the institution vide dated 31.05.2015 for B.Ed. course with an annual intake of 100 students with a direction to submit the compliance to the Revised Recognition order on or before 06.08.2015.

3. And whereas, the matter was placed before the WRC in its 255th meeting held on 22-24 June, 2016 to verify the compliance of NCTE Regulations, 2014 and the Committee decided to issue show cause notice dt. 20.03.2017.

4. And whereas, the institution has not submitted any reply and the matter was placed before the WRC in its 311th meeting held on September 25th - 27th, 2019 and the Committee has decided as follows:-

"The Show Cause Notice was issued to the institution vide letter dated 20/03/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

5. AND WHEREAS, a withdrawal Order No. WRC/APW05418/123672/311th/2019/206719 to 206726 dated 11.10.2019 was issued to the institution.

6. AND WHEREAS, the institution had filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 11.02.2021 has decided as follows:-

"After perusal of the Memoranda of appeal, affidavit, documents on record and oral arguments advanced during the hearing, appeal committee concluded to remand back the case to WRC with a direction to consider the documents submitted in appeal to be sent to them by the appellant and take further necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the WRC all the documents submitted in appeal within 15 days of receipt of orders on the appeal.

The Council hereby remands back the case of KONKAN MUSLIM EDUCATION SOCIETY'S COLLEGE OF EDUCATION, THANE ROAD, BHIWADI, THANE, MAHARASHTRA to the WRC, NCTE, for necessary as indicated above."

7. AND WHEREAS, the institution has submitted its reply on dated. 15.02.2021 and the matter was considered by WRC in its 336th meeting, held on 24th - 25th March, 2021 and the committee decided as follows: -

"The Original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observations was made that :-

On the perusal of the reply submitted by the Institution, the Committee decided that the continuation order be issued to the Institution COLLEGE OF EDUCATION B.ED, KONKAN MUSLIM EDUCATION SOCIETY, H.NO. 15B, RAIS HIGH SCHOOL CAMPUS, THANE ROAD, BHIWANDI, DIST. THANE, MAHARASHTRA - 421302, MAHARASHTRA for B.Ed. programme for 2 basic units of 50 students in each unit."

8. Now Therefore, the WRC decided to permit the Institution i.e. COLLEGE OF EDUCATION B.ED, KONKAN MUSLIM EDUCATION SOCIETY, H.NO. 15B, RAIS HIGH SCHOOL CAMPUS, THANE ROAD, BHIWANDI, DIST. THANE, MAHARASHTRA - 421302 for continuation of recognition for B.Ed. course of two-years duration with an Intake of 100 students (Two basic unit) from Withdrawal Order no. WRC/APW05418/123672/311/2019/206719 TO 206726 dated 11.10.2019 subject to fulfillment of the following conditions:-

- a) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - c) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - d) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
 - e) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
14. Further, the Institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
15. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
16. The institution shall maintain its Website with hyperlink to the Council and the Western Regional Committee, covering, inter - alia, the details of the Institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
- a) Sanctioned programme(s) along with annual intake in the institution.
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter;
 - d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.

 - f) Available infrastructural facilities.
 - g) Facilities added during the last quarter;
 - h) Numbers of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information, if it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
18. The institution shall make available the list of students admitted on its official website.
19. The institution shall fill the information on GIS Portal on the NCTE Website.
20. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Western Regional Committee under the provisions of Section 17 of the NCTE Act, 1993.
